# Superintendent's Report

Superintendent Bruce reported he met with Connie Kliewer from the ESD about changing the testing format for highly capable. Bruce reported the Ag Advisory committee met last Tuesday with seven in attendance. Superintendent Bruce shared the district is proposing to run an educational programs and operation levy, a capital levy, and a one-year transportation vehicle fund levy after the loss of two buses due to a transmission failure and a recent bus incident. Bruce finished by informing the school board that no one responded to the advertisements for the For/Against Committee for the upcoming levies.

#### Principal's Report

Principal Nelson reported a head count of 220 students.

Nelson shared National Honor Society Inducted the following students: Collin Martin, Jacob Scrupps, Hayden Schuh, Melloney Deife, Lily Starkel, Mackenzie Lutz, Reegan Carstensen, Casen Watson and Holden Iverson. NHS packed and delivered over thirty Thanksgiving baskets to members of the community.

Nelson also reported elementary parent/teacher conferences were well attended while secondary had a low turnout. Students who received the Tiger Pride award in October and November celebrated their STAR behavior with a pizza lunch. A Veterans Day assembly was held to honor our local veterans on November 10<sup>th</sup>.

Principal Nelson shared staff members are discussing future training opportunities to strengthen intervention programs for math and ELA. Other areas of focus are leadership opportunities for middle school students and a credit recovery plan to support students who have not passed state required graduation courses.

# **AD Report**

Athletic Director Larry Weber shared the high school football team will play in the semifinals against Liberty Bell on Saturday, November 26<sup>th</sup> in Moses Lake. The high school volleyball team finished 4<sup>th</sup> in Districts and placed 6<sup>th</sup> in state competitions. Melloney Deife and Hayden Schuh made the all-opponent team.

Weber reported the junior high basketball girls have started playing games with 16 participants and are coached by Abby Lindberg and Sidney Sheer. The junior high boys have 15 participants signed up with Deric Schmlerer and Mike Carlquist as coaches pending board approval.

High school basketball practice started November 14<sup>th</sup> with 16 girl participants and 23 boy participants. Mike Carlquist will fill the high school assistant boys coaching position pending board approval. The new uniforms for the girls have arrived. Next on the rotation list to received new uniforms is high school boys basketball in 2023 followed by high school football jerseys in 2024.

Weber shared the high school head baseball and junior high head baseball coaching positions are available.

# **Legislative Report**

Superintendent Bruce shared items considered on the legislative agenda this year involve fully funding special education, school meals, and transportation. A heavy focus will be on equity in education experiences and opportunities.

# **Facilities Report**

Justin Parr reported Kysar Mechanical is evaluating and creating a plan to solve the pipe leak in the elementary wing. The sprinklers have been blown out and the water has been turned off for winter. Parr also discussed bus driver and custodian staffing issues.

Parr shared the insurance money from the recent bus incident will be used to purchase a used bus pending board approval. The wrecked bus will be donated to the Odessa Fire Department by the insurance company.

#### **Financial Report**

Superintendent Bruce presented the ASB balance sheet for October. He further presented the Financial Activity reports for General Fund for October showing an unassigned fund balance of \$799,366.09. He presented computer printouts for all funds.

"Whereas, the funds available for Odessa School District #105-157-166J through presently scheduled programs are insufficient to meet the needs of the district, and ---- Now, therefore, be it here by resolved --- that a special levy be held in the aforesaid district on the 14th day of February, 2023, ----- Which shall be submitted to the electors of said district for their approval or rejection in the form of the following ballot title: "be authorized to levy a one-year replacement tax levy be collected in the year 2024, the sum of \$125,000, requiring approximately \$0.37 per \$1,000 of assessed valuation --- to be placed in the Capital Projects Fund to be used to support the modernization of school facilities --- of Odessa School District #105, Lincoln County, joint with #157, Adams County and #166J Grant County?" -- The aforesaid resolution was adopted at a regular meeting of the Board of Directors of the aforesaid district on the 22nd day of November, 2022 -"
